



Electronic Statement Delivery Consent and Authorization: Thank you for your interest in UniBank's Electronic Communication Delivery service. This service will allow you to electronically receive and view your current and past account statements, disclosures related to accounts opened online, and any subsequent disclosures or notices through our secure website.

To receive and review communications electronically, and to view, download and print your electronic statements and or disclosures you will need the following: a computer connected to the Internet, and Adobe Acrobat Reader 10.0 or higher in order to read electronic statements. We also recommend that you use the latest browser version available that supports 128-bit SSL Encryption. Visit: <https://www.unibank.com/supported-browsers/> for a list of supported browsers. You will receive electronic statements for all the accounts you select in lieu of paper statements.

You may withdraw consent or update your e-mail address at any time in person, at any branch location, by telephone at 800.578.4270, or by e-mail at customer.service@unibank.com. Your withdrawal of consent will become effective no later than fifteen (15) days after your request. Upon termination you will no longer have access to your account statements online and you will receive all subsequent electronic communications in paper form through the postal mail service. An invalid e-mail address, or the subsequent malfunction of a previously valid e-mail address will be deemed as a withdrawal of consent to receive electronic communications. It is your responsibility to keep your email address updated with us.

Electronic delivery of initial account opening disclosures will only be available for accounts opened online. Delivery of electronic statements will be available for all accounts for which you receive periodic statements such as your checking, savings, money market, statement CD, mortgage and home equity accounts. You will also have the option to select account(s) for which you wish to continue to receive paper statements.

For joint accountholders, any consent or withdrawal of consent to receive electronic communications by any one of you will be effective for all of you. With this consent form you are also consenting to receive in electronic format any subsequent notices, disclosures, change in terms, or notice of insufficient funds in connection with your account and any other notices that may be required by law.

You may request a paper copy of your account statement or this Agreement. You will be charged a statement copy fee for each statement that you request, per our Schedule of Service Fees.

IMPORTANT: PLEASE PRINT AND RETAIN THIS CONSENT AND AUTHORIZATION. All communications in either electronic or paper format from the Bank to you will be considered "in writing." You should print or download for your records a copy of this authorization and any other communication that is important to you for your records.

By clicking "I Accept", you agree to the terms and conditions of this Consent and Authorization. You further agree that: the computer you will use for the receipt of electronic materials will meet the hardware and software requirements of this agreement, you have the ability to print or electronically save your electronic communications, you have the ability to visually display electronic communications on your computer screen, you will maintain a valid, active e-mail address, you will notify the Bank promptly of a change to your e-mail or postal address, and you will be notified by email when new electronic communications are available for viewing.
